### **COUNTY OF LEWIS**

#### **Local Law No. 1 of the Year 2021**

#### **A LOCAL LAW PROVIDING FOR INCREASES TO SALARIES FOR CERTAIN LOCAL OFFICIALS**

BE IT ENACTED by the Board of Legislators of the County of Lewis as follows:

##### SECTION 1.

Commencing and effective January 1, 2021, the Compensation Plan of the County of Lewis shall be amended to provide the following salaries for the following County employees appointed to a fixed term of office, to-wit:

Clerk of the Board	\$ 55,758
Commissioner, Department of Social Services	\$ 81,163
County Attorney	\$113,196
Director of Real Property Tax Service	\$ 57,395
Director of Human Resources/Personnel Officer	\$ 83,482
County Manager	\$101,405

##### SECTION 2.

This Local Law is subject to a permissive referendum and shall take effect forty-five (45) days after the adoption hereof and all legal requirements having been met.

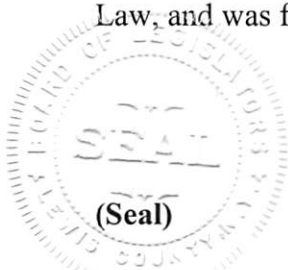
